### General Rules for All Exhibitors

1. All sanctioned classes are open to Jack Russell Terriers only.
2. Exhibitors and owners of terriers entered must be current JRTCA members, and must not be a member of a conflicting JRT organization or register their JRTs in any all breed registry or conflicting JRT organization registry. If an exhibitor is found to be in violation of this policy, entry will be disqualified and no refunds given. If a violation is confirmed after the trial, placements will be voided from all JRTCA records. Exhibitors must submit a completed entry form including a signed waiver for every trial they enter.
3. Entries MUST be within the 10-15" JRTCA height standard for all sanctioned classes (with the exception of pups who have not yet met the 10" height standard); measuring devices will be available on the trial grounds.
4. Puppies (under 12 months of age) are not eligible for championship in any division but their own. Puppies are eligible to compete only if they have reached their four-month birthday (not 16 weeks). A puppy's age is the actual age the pup is on the day of the trial.
5. Bitches in season may not compete in any division. Pre-entry fees of bitches in season to be refunded with vet certificate from owner, or as otherwise agreed upon by the Trial Chairman.
6. Spayed or neutered terriers may compete in Miscellaneous Conformation. They may not compete in Puppy, Family\*, Open or Working Conformation. \*Note: For Family Classes, Brood Bitches and Stud Dogs entered may not be spayed/neutered. The offspring at their sides may be intact or spayed/neutered.
7. A terrier bred by a Sanctioned JRTCA Judge may not be shown under that Judge in the Conformation division.
8. Terriers owned or co-owned by the Trial Chairperson, or any member of their household may not be entered in any phase of the competition, with the exception of Child and Youth Handling.
9. Terriers owned by judges may not be entered in the division in which they are judging, but may enter the competition in any other division.
10. Terriers owned by stewards may be entered in any division provided that they find a substitute to perform their duties or have someone else show their terriers.
11. Requests for the measurement of a terrier being shown in any class may be made only by another exhibitor in that class or by the judge. These measurements will be considered the official height of the terrier in question. Requests made by spectators will not be honored. Only JRTCA height cards issued after September 1999 will be honored.
12. Excessive use of squeaky or fur-like baiting devices by exhibitors is prohibited in the Conformation ring and may result in the exhibitor being excused from the class. "Excessive use" will be at the judge's discretion.
13. Exhibitors participating in the JRTCA Working Terrier classes or Certificate Go-to- Ground must submit the appropriate JRTCA certificates with pre-entries or at the time of post-entry. The Judge may require a copy of the certificate be presented to the ring/den steward at the time of judging. Registered terriers may submit a copy of NHC application signed by a JRTCA Working Judge within 30 days of the date it was issued.
14. Puppies under the age of three months are not permitted on the trial grounds. Any person violating this rule will be excused from all classes entered, and asked to leave the trial site.
15. All dogs must be leashed or crated except when competition requires off leash work. No liberty leashes allowed.
16. Overly aggressive dogs, or an owner's failure to control his/her dog, may result in disqualification at the discretion of the judges or the Trial Chairperson.
17. The abuse or severe disciplining of dogs on the trial grounds is prohibited. Anyone displaying such behavior will be asked to leave the trial site, and no entry fees will be refunded.
18. Dogs, other than JRTs, on the grounds may be excluded or permitted at the discretion of the Trial Chairperson.
19. Exhibitors are responsible to double-check the classes they have entered and be on time. No refunds will be given for missed classes.
20. The owner/handler of a terrier entering any class does so at his/her own risk and agrees to abide by the rules of the JRTCA and the trial. A copy of the JRTCA Rule Book can be obtained by contacting the JRTCA office (410-561-3655), or it can be downloaded from the JRTCA web site ([www.terrier.com](http://www.terrier.com)).
21. Unsportsmanlike conduct, or the use of foul and abusive language, will not be tolerated. Anyone demonstrating such conduct will be asked to leave the trial site and no entry fees will be refunded. In addition, such conduct will be subject to penalties, which may include the suspension of membership, restriction from entering the JRTCA National Trial, and/or fines. Trial Chairpersons have the right to refuse any entry at their sole and absolute discretion.
22. All dogs brought to JRTCA Sanctioned Trials must be current on vaccinations. No dogs of any age may be brought to a trial who have suspicion of contagious or infectious disease.

### 23. THE JUDGES' DECISIONS CONCERNING PLACEMENTS ARE FINAL IN ALL DIVISIONS!

**If your terrier is not registered or recorded there will be an additional \$5.00 JRTCA fee per day per dog.**  
**Total of \$7.00 per dog/per day for administration fees if the JRT is not registered with the JRTCA.**  
**This does not apply to puppies under 12 months old. Non-Sanctioned classes do not have a per dog fee.**

Exhibitors are responsible for knowing the JRTCA rules of each division. The JRTCA Rule Book can be obtained from the JRTCA office (410) 561-3655, or downloaded (pdf format) from the JRTCA web site ([www.terrier.com](http://www.terrier.com))

Every effort was made to schedule classes so you may enter as many events as possible. It is your responsibility to be aware of the scheduled classes, in each division, and to be on time for every class. The trial will not be responsible for conflicts that may occur and classes WILL NOT be held up due to conflicts between events. Please review the class list and schedule carefully. Plan your classes accordingly

#### Important Notices for Exhibitors

- Every effort will be made to start trial events on time. **Dogs late to racing or conformation will be scratched. NO REFUNDS for missed classes.**
- REFUNDS for classes will be given ONLY in cases of accident or illness of a terrier or owner, or for bitches in season. Situations must be documented in writing. Refunds provided by mail within 14 days following the trial.
- ENTRIES must be postmarked by June 17, 2011. Entries postmarked after that date will be considered post entries and charged accordingly. Please pre-enter for the trial, this helps the trial run smoother and is cheaper for you. No phone entries, please.
- CLASSES may be combined if insufficient entries are received.
- CROSS ENTERING is not permitted within the Open Section of the Conformation Division. Also, terriers may not enter both the Open and Working sections.
- RIBBONS 1<sup>st</sup> to 6<sup>th</sup>
- RAFFLE – Please support the raffle by donating at least one raffle prize.
- VENDORS – No fee is required; however, vendors are required to furnish a nice raffle prize. Please support the vendors.
- **No Alcoholic Beverages allowed in the Park**
- **Clean up after your dogs**
- No Post Entries for the JRTCA racing
- Colored Terrier owners DO NOT have to be members of the JRTCA to compete.
- All payments must be in US currency, US Banks.

## Racing Rules

1. ALL TERRIERS MUST BE MUZZLED! Plastic basket muzzles or close-ended cloth muzzles only. No figure eight or open-ended muzzles will be allowed.
2. Any terrier entering the catch area during a race without a secured muzzle will be disqualified. No refund will be given.
3. Exhibitors must have entries ready to race, be aware of their classes, and be ready when called. In the event a heat is missed, permission to run in a later heat is granted at the discretion of the racing judge or steward. There are no refunds for missed classes.
4. Once entries are loaded into the starting gate, all handlers shall proceed to the finish line and be ready to receive their terriers.
5. In a hurdle race, any entry going around the jumps will be disqualified.
6. Senior hurdle races must be run over lower height hurdles.
7. If a brush or lure is caught or in some way, or the movement or lack of movement of the lure delays or alters the forward motion of any terrier (i.e., almost caught or flies outside the track) the race will be rerun.
8. Entries must cross the finish line completely to place in a race. The finish line is the backside of the barrier. First to the hole is not necessarily first through the hole!
9. Any terrier engaged in fighting shall be disqualified by the Racing Judge from any further racing during the trial. No refund will be given.
10. Racing Champions are determined by a run-off of the first place terrier in each class in each section. To be eligible to run in the Championship race, the terrier MUST have entered and RUN in both the flat and steeplechase classes. A terrier that is not entered in both classes or has not run in both classes is not eligible to run in the Championship race. In this case, the 2nd place terrier becomes eligible to run in the Championship race, assuming it was entered and ran in both classes.
11. Once the Racing Division has begun, NO requests for measurement will be honored.
12. Adult terriers may not cross-enter between Regular Racing Classes, Veteran Racing Classes and Senior Racing Classes.

Open to 1st place winners of classes 2, 4, 14, 16. *No entry fee.*

Open to 1st place winners of classes 3, 5, 15, 17. *No entry fee.*  
Class 20 : Dogs, 1 year and older, 10" up to 12½"  
Class 21 : Dogs, 1 year and older, over 12½" up to 15"  
Class 22 : Bitches, 1 year and older, 10" up to 12½"  
Class 23 : Bitches, 1 year and older, over 12½" up to 15"  
Class 24 : Veterans, 6 years and older, 10" up to 12½"



- Class 25 : Veterans, 6 years and older, over 12½" up to 15"  
 Class 26 : Colored & Novice Terrier, 10" up to 12 ½" (*NON - SANCTIONED*)  
 Class 27 : Colored & Novice Terrier 12 ½" up to 15" (*NON – SANCTIONED*)  
 Class 28 : **10" up to 12½" ADULT CHAMPIONSHIP.**  
 Open to 1st place winners of classes 6, 8, 20 & 22. *No entry fee.*  
 Class 29 : **Over 12½" up to 15" ADULT CHAMPIONSHIP.**  
 Open to 1st place winners of classes 7, 9, 21, 23. *No entry fee.*  
 Class 30 : **VETERANS, 10" up to 12½", RACING CHAMPION & RESERVE**  
 Open to 1st place winners of classes 10 & 24. *No entry fee.*  
 Class 31 : **VETERANS, over 12½" up to 15", RACING CHAMPION & RESERVE**  
 Open to 1st place winners of classes 11 & 25. *No entry fee.*  
 Class 32 : **COLORED & NOVICE TERRIERS, 10" up to 12½", RACING CHAMPION & RESERVE**  
 Open to 1st place winners of classes 12 & 26. *No entry fee. (NON SANCTIONED)*  
 Class 33 : **COLORED & NOVICE TERRIERS, over 12½" up to 15", RACING CHAMPION & RESERVE** Open to 1st place winners of classes 13 & 27. *No entry fee. (NON SANCTIONED)*

## Division B: Youth / Child

**Child Handler, Youth Handler, and Youth Go-To-Ground are mandatory classes for every trial. and must be the first conformation classes of the day. The Youth Division is listed as an entirely separate division. Please note that these classes are not included in any other division of the Trial. Youth / Child handlers must compete with the same terrier in each class. Youth handlers must compete with a terrier that is at least 1 year of age. Sponsored by Angie Eggerling**

Class 34 : **Child Handler.** Open to any child aged 5 through 9, handling a Jack Russell Terrier, six months of age or older. This class is offered as an introductory experience in handling and learning about the Jack Russell Terrier. Judged on child's ability to present his/her dog and beginning knowledge of the Jack Russell. Quality of the dog NOT to be considered.

Class 35 : **Youth Handler.** Open to any youth aged 10 through 16, handling an **adult** Jack Russell Terrier. Judged on the youth's ability to present his/her dog and knowledge of the Jack Russell Terrier. Quality of the dog NOT to be considered.

Class 36 : **Youth G-T-G.** Open to any youth aged 10 through 16, handling an **adult** Jack Russell Terrier. Judged on the youth's ability to present his/her dog and knowledge of Go-To-Ground. To be run through the 10-foot Novice liner; time not to be considered.

Class 37 : **Child G-T-G.** (Non-Sanctioned) Open to any youth aged 5 through 9, handling an adult Jack Russell Terrier. Judged on the youth's ability to present his/her dog and knowledge of Go-To-Ground. To be run through the 10-foot Novice liner; time not to be considered.

### Class 38 : YOUTH HANDLER HIGH SCORE & RESERVE

Awarded to the highest scoring youth and runner-up in classes 35 through 36.

The points are awarded as follows: 1st = 8 points; 2nd = 6 points; 3rd = 5 points; 4th = 4 points; 5th = 3 points; 6th = 2 points; and participation = 1 point.

Exhibitors must compete in a minimum of Youth Handling and Youth Go-to-Ground to qualify for the Youth High Score & Reserve. In the case of a tie, it will be broken by a handling class to be held in the Conformation Ring; judge to be decided by the Trial Administrator.

### Class 39 : CHILD HANDLER HIGH SCORE & RESERVE (NON-Sanctioned)

Awarded to the highest scoring youth and runner-up in classes 34 and 37.

The points are awarded as follows: 1st = 8 points; 2nd = 6 points; 3rd = 5 points; 4th = 4 points; 5th = 3 points; 6th = 2 points; and participation = 1 point.

Exhibitors must compete in a minimum of Child Handling and Child Go-to-Ground to qualify for the Child High Score & Reserve. In the case of a tie, it will be broken by a handling class to be held in the Conformation Ring; judge to be decided by the Trial Administrator.(Non-Sanctioned)

## Conformation Rules:

1. All terriers are to be judged on the JRTCA Breed Standard, unless otherwise noted.
2. Classes may be combined or split at the discretion of the Trial Chairperson.
3. A terrier bred by a Sanctioned JRTCA Judge may not be shown under that judge in the Conformation division.
4. A question concerning the type of coat on any terrier may be made only by another exhibitor in that class, the ring steward or by the judge. Requests for review of coat made by spectators will not be honored.
5. Spayed or neutered terriers may not compete in the Puppy, Family\*, Open Adult or Working Conformation section classes. Miscellaneous Conformation section classes are optional and offered at the discretion of the Trial Chairperson. When optional classes are offered they must be judged by a Sanctioned JRTCA Judge and follow the JRTCA sanctioned trial rules. **\*Note:** For Family Classes, Brood Bitches and Stud Dogs entered may not be spayed/neutered. The offspring at their sides may be intact or spayed/neutered.
6. No cross entering is permitted within the Open and Working Conformation section or between the Open and Working Conformation section.
7. Exhibitors participating in the Working classes must submit appropriate JRTCA paperwork with entries. The judge may require a copy of the Natural Hunting Certificate be presented to the ring steward at the time of judging.

8. Registered terriers may submit a copy of NHC Application, signed by a JRTCA Working Judge, within 30 days of the date it was issued.
  9. Excessive use of squeaky or fur-like baiting devices by exhibitors is prohibited in the Conformation ring. "Excessive use" will be at the judge's discretion.
  10. The only individuals permitted in the Conformation ring, other than class participants are the judge or the ring steward, and if asked for by the judge or ring steward, the Trial Chairperson and trial photographer. Class participants include one handler per terrier. Terrier must be exhibited on lead.
  11. Puppies, 12 months of age and younger, are not eligible to enter any Miscellaneous Conformation or Suitability classes except Spayed/Neutered 6-12 month Puppy class, if it is offered.

### **SECTION 1: 4 UP TO 6 MONTH PUPPY CONFORMATION**

Class 40 : Dog Pups, 4 up to 6 months, smooth.

Class 41 : Dog Pups, 4 up to 6 months, rough/broken.

Class 42 : **BEST 4 UP TO 6 MONTH DOG PUPPY & RESERVE.** Open to the 1st and 2nd place winners of classes 40 and 41. *No entry fee.*

Class 43 : Bitch Pups, 4 up to 6 months, smooth.

Class 44 : Bitch Pups, 4 up to 6 months, rough/broken.

Class 45 : **BEST 4 UP TO 6 MONTH BITCH PUPPY & RESERVE.** Open to the 1st and 2nd place winners of classes 43 and 44. *No entry fee.*

Class 46 : **BEST 4 UP TO 6 MONTH PUPPY & RESERVE.** Open to the 1st and 2nd place winners of classes 42 and 45. *No entry fee.*

### **Section 2 : 6-12 MONTH PUPPY CONFORMATION**

Class 47 : Dog Pups, 6 up to 9 months, smooth.

Class 48 : Dog Pups, 6 up to 9 months, rough/broken.

Class 49 : Dog Pups, 9 up to 12 months, smooth.

Class 50 : Dog Pups, 9 up to 12 months, rough/broken.

Class 51 : **BEST PUPPY DOG & RESERVE.** Open to 1st and 2nd place winners of classes 47 through 50. *No entry fee.*

Class 52 : Bitch Pups, 6 up to 9 months, smooth.

Class 53 : Bitch Pups, 6 up to 9 months, rough/broken.

Class 54 : Bitch Pups, 9 up to 12 months, smooth.

Class 55 : Bitch Pups, 9 up to 12 months, rough/broken.

Class 56 : **BEST PUPPY BITCH & RESERVE.** Open to 1st and 2nd place winners of classes 52 through 55. *No entry fee.*

Class 57 : **PUPPY CONFORMATION CHAMPION & RESERVE.** Open to Best Dog Puppy & Reserve and Best Bitch Puppy & Reserve. Classes 51 & 56 *No entry fee.*

**Section 3 : JRTCA WORKING TERRIER CONFORMATION.** Open to any JRTCA registered terrier owned by a JRTCA member which holds a JRTCA Natural Hunting Certificate. Terriers entering the Working Section may **not** cross-enter into the Open Section; no cross-entering is permitted within the Working Section. Classes may be combined by height and coat type at the Trial Chairperson's discretion.

Class 58 : Bronze Medallion Dog. Open to any dog which has earned the JRTCA Bronze Medallion for Special Merit in the Field.

Class 59 : Working Terrier Dog, 10 up to 12½", smooth

Class 60 : Working Terrier Dog, 10 up to 12½", rough/broken

Class 61 : Working Terrier Dog, over 12½ up to 15", smooth

Class 62 : Working Terrier Dog, over 12½ up to 15", rough/broken

Class 63 : **BEST WORKING TERRIER DOG & RESERVE.** Open to 1st and 2nd place winners of classes 58 through 62. *No entry fee.*

Class 64 : Bronze Medallion Bitch. Open to any bitch which has earned the JRTCA Bronze Medallion for Special Merit in the Field.

Class 65 : Working Terrier Bitch, 10 up to 12½", smooth

Class 66 : Working Terrier Bitch, 10 up to 12½", rough/broken

Class 67 : Working Terrier Bitch, over 12½ up to 15", smooth

Class 68 : Working Terrier Bitch, over 12½ up to 15", rough/broken

Class 69: **BEST WORKING TERRIER BITCH & RESERVE.** Open to 1st and 2nd place winners of classes 64 through 68. *No entry fee.*

Class 70 : **WORKING TERRIER CONFORMATION CHAMPION & RESERVE.** Open to Best Working Terrier Dog & Reserve and Best Working Terrier Bitch & Reserve. *No entry fee.*

**Section 4: OPEN ADULT CONFORMATION.** No cross-entering is permitted within the Open Section. Cross-entering is **not** permitted between the Open Section and the Working Section.

**Class 71 : Bred by Exhibitor Dog.** Open to any adult Jack Russell Terrier owned and bred by the exhibitor; must be handled by the breeder *under whose kennel prefix the terrier is registered* or a member of the breeder's immediate family.

**Class 72 :** Dogs, 1 year and older, 10 up to 12½", smooth

**Class 73 :** Dogs, 1 year and older, 10 up to 12½", rough/broken

**Class 74 :** Dogs, 1 year and older, over 12½ up to 15", smooth

**Class 75 :** Dogs, 1 year and older, over 12½ up to 15", rough/broken

**Class 76: BEST DOG & RESERVE.** Open to 1st and 2nd place winners of classes 71 through 75. *No entry fee.*

**Class 77 : Bred by Exhibitor Bitch.** Open to any adult Jack Russell Terrier owned and bred by the exhibitor; must be handled by the breeder *under whose kennel prefix the terrier is registered* or a member of the breeder's immediate family.

**Class 78 :** Bitches, 1 year and older, 10 up to 12½", smooth

**Class 79 :** Bitches, 1 year and older, 10 up to 12½", rough/broken

**Class 80 :** Bitches, 1 year and older, over 12½ up to 15", smooth

**Class 81 :** Bitches, 1 year and older, over 12½ up to 15", rough/broken

**Class 82 : BEST BITCH & RESERVE.** Open to 1st and 2nd place winners of classes 77 through 81. *No entry fee.*

**Class 83 : BEST OPEN TERRIER & RESERVE.** Open to Best Dog & Reserve and Best Bitch & Reserve. *No entry fee.*

#### **Section 5: FAMILY**

**Class 84 : Stud Dog & Get.** Open to a sire with at least two, but not more than three offspring at parent's side. Judged on Breed Standard and consistency of type. Stud Dog must be an intact male. Offspring may be intact or spayed/neutered.

**Class 85 : Brood Bitch & Produce.** Open to a dam with at least two, but not more than three offspring at parent's side. Judged on Breed Standard and consistency of type. Brood Bitch must be an intact female. Offspring may be intact or spayed/neutered.

**Class 86 : BEST FAMILY & RESERVE.** Open to 1st and 2nd place winners in classes 84 & 85. *No entry fee.*

#### **Section 6: MISCELLANEOUS. Open to any adult JRT including those spayed and neutered.**

Bred on breed standard unless otherwise noted.

**Class 87: Spayed/Neutered Working Terrier.** Open to any adult Spayed/Neutered Jack Russell Terrier, which holds a JRTCA Natural Hunting Certificate.

**Class 88 : Novice.** Open to any adult Jack Russell which has never placed 1st through 4th in an adult regular or 1st in any Novice Conformation Class, at this or ANY prior sanctioned trial.

**Class 89: Neutered Dog**

**Class 90: Spayed Bitch**

**Class 91 : Veteran Terrier.** Open to any Jack Russell Terrier six years or older. Judged on the Breed Standard and condition of the dog.

**SUITABILITY - JUDGE'S CHOICE.** Open to any adult Jack Russell Terrier, including those which have been spayed/neutered. The dog the judge would choose to take hunting to each quarry listed below.

**Class 92 : Suitability to Red Fox.**

**Class 93 : Suitability to Groundhog.**

**Class 94 : Suitability to Raccoon/Badger.**

**Class 95 : Matched Pairs Class – (Non Sanctioned & Free to enter)**

The Best Matched couple of terriers (pairs). Judged on pair that MOST resembles each other. Terriers may be intact or altered, any age or sex. Terriers do NOT have to be owned by the same person

---

#### **Go-to-Ground Rules**

1. Schooling prior to the competition is NOT permitted. Any violation of this rule shall result in disqualification from Go-To-Ground competition at this trial. No entry fees will be refunded.
2. Exhibitors are expected to pick up score sheets for their terriers at the Secretary's stand. At the time of the competition, the exhibitor will give the score sheet to the Den Steward for scoring by the Judge.
3. Exhibitors are encouraged to read the score sheets and class descriptions carefully, and review and abide by the JRTCA Rules for Go-To-Ground.
4. A line approximately two feet from entrance hole will be designated as the starting line. Time starts when the terrier is released. Time starts when the terrier is released. The terrier is to be released so that all four of the terrier's feet are on the ground before crossing the starting line. Any violation of this rule, accidental or intentional shall result in disqualification of the terrier from the class in which the violation occurs. No entry fees will be refunded.

5. After the terrier is released, the handler shall remain next to the entrance hole. Once the terrier has entered, the handler may not block the entrance hole by standing in it or in any other manner. Commands and encouragement may be given. The Judge will signal to the exhibitor to pickup the terrier at the completion of their work.
6. The judge signals the release of the terrier. Do not release your terrier until the judge signals. Any violation of this rule, accidental or intentional shall result in disqualification of the terrier from the class in which the violation occurs. No entry fees will be refunded.
7. Terriers, puppies and adults, registered or non-registered, which have previously scored 100% in the Novice at a JRTCA trial may not, under any circumstances, compete in these classes at any sanctioned trial.
8. Puppies who have earned 100% in the Open Puppy Class at this trial may, upon payment of the entry fee enter the Puppy Championship Class at this trial and must compete in the Puppy Championship Class at all future trials. Winners of this class will determine the Puppy GTG Champion & Reserve.
9. Terriers, one year old or older, registered or non-registered, which have previously scored 100% in the Open class **must** continue to compete in the Open Adult class until they receive their Trial Certificate. A terrier achieving 100% in the Open Adult class is eligible to apply for a Trial Certificate when the terrier is registered or recorded with the JRTCA. **No adult terrier may compete in the Championship Certificate class until the Trial Certificate has been applied for and issued.**
10. To obtain a Trial Certificate after scoring 100% in an Open Class at a JRTCA Sanctioned Trial, the owner of the adult terrier shall submit a copy of the qualifying score sheet, **signed and initialed by the GTG judge**; along with a \$20.00 filing fee, to the JRTCA office. The score sheet is good for the life of the dog and may be submitted with the registration application if the terrier is not already registered/recorded with the JRTCA.

**DIVISION D: GO-TO-GROUND**

**Class 96 : Pre-Novice Puppy.** Open to Jack Russell puppies 4 up to 6 months. Entry in Pre-Novice Puppy class does not affect the puppy's eligibility to enter the Novice Class after 6 months of age. (One minute to reach quarry; mark quarry for 15 seconds; may leave earth and re-enter.)

**Class 97 : Novice Puppy:** Open to Jack Russells 6 up to 12 months which have not scored 100% in this class at a previous JRTCA trial. Entries earning a score of 100% at this trial may, upon payment of the entry fee, enter the Open Puppy Class at this trial. (One minute to reach quarry; may leave earth and re-enter several times; work quarry for 30 seconds.)

**Class 98 : Novice Adult:** Open to Jack Russells one year of age or older which have not scored 100% in this class at a previous JRTCA trial. Entries earning a score of 100% at this trial may, upon payment of the entry fee, enter the Open class at this trial. (One minute to reach quarry; may leave earth and re-enter several times; work quarry for 30 seconds.)

**Class 99 : Open Puppy.** Open to Jack Russells 6 up to 12 months which have scored 100% in a Novice Go-To-Ground class at this or a previous JRTCA trial. Not open to any puppies which have previously achieved 100% in this class. Puppies earning a score of 100% at this trial may, upon payment of the entry fee, enter the Puppy Championship GTG class at this trial. (30 seconds to reach quarry; may leave earth once and re-enter; work quarry for one minute.)

**Class 100 : Open Adult.** Open to Jack Russells one year or older which have scored 100% in a Novice Go-To-Ground class at this or a previous JRTCA trial. (30 seconds to reach quarry; may leave earth once and re-enter; work quarry for one minute.)

**Class 101: Puppy Championship.** Open to Jack Russells, 6 up to 12 months which have earned 100% in an Open Go-To-Ground class at this or a previous JRTCA trial. A copy of a 100% Open score sheet shall be submitted with pre-entry or be shown to the Den Steward at the time of the class. First and second place winners will be Puppy Go- To-Ground Champion and Reserve. (30 seconds to reach quarry; may leave earth once and re-enter; work quarry for one minute.)

**Class 102: 10 up to 12½" Championship Certificate.** Open to any adult Jack Russell 10 up to 12½", one year and over, which holds a JRTCA Trial Certificate. A copy of the certificate must be submitted with pre-entry or be shown to the Den Steward at the time of the class. First and second place winners will be Go-To-Ground Champion and Reserve. (30 seconds to reach quarry; may not leave earth; work quarry for one minute.)

**Class 103: Over 12½ up to 15" Championship Certificate.** Open to any adult Jack Russell over 12½ up to 15", one year and over, which holds a JRTCA Trial Certificate. A copy of the certificate must be submitted with pre-entry or be shown to the Den Steward at the time of the class. First and second place winners will be Go-To-Ground Champion and Reserve. (30 seconds to reach quarry; may not leave earth; work quarry for one minute.)

**Class 104: Veteran Certificate.** Open to any adult Jack Russell 6 years of age or older, who holds a JRTCA Trial Certificate. **CROSS-ENTERING IS NOT PERMITTED BETWEEN CERTIFICATE CLASSES.** (30 seconds to reach quarry; may not leave earth; work quarry for one minute.)

**DIVISION E. NON SANCTIONED CLASSES FOR COLORED/NOVICE TERRIER TYPES**

**Only \$5.00 fee per Class**

**Wondrous Earth Go to Ground Rules (Non-Sanctioned)**

1. Wondrous Earth is open to any terrier type that will fit in the tunnel.
2. Schooling prior to competition is NOT permitted. Any violation of this rule shall result in disqualification from Wondrous Earth competition at this trial. No entry fees will be refunded.
3. Terriers entered in Wondrous Earth may also compete in their regular GTG classes.
4. Exhibitors are expected to pick up Wondrous Earth score sheets at the Secretary's stand. At the time of competition, the exhibitor will give the score sheet to the Den Steward for scoring by the judge.

5. The organizers will designate a starting line. Time starts when the terrier is released. The judge signals the release of the terrier. Do not release the terrier until the judge signals. Any violation of this rule, accidental or intentional, shall result in disqualification of the terrier from the class. No entry fees will be refunded.
  6. After the terrier is released, the handler will remain at the starting line. Commands and encouragement may be given. The judge will signal to the exhibitor to pick up the terrier at the completion of their work.
  7. In the event of a tie, the tie shall be broken by a run-off; the fastest time shall determine the winner.

**Section 1. Wondrous Earth GO-TO-GROUND (Non-Sanctioned)**

**Class 108: 10 up to 12½” Veteran Wondrous Earth.** Open to terrier types six years and older *(Non-Sanctioned)*.

**Class 109: Over 12½ up to 15” Veteran Wondrous Earth.** Open to terrier types six years and older. *(Non-Sanctioned)*

**Section 2. Conformation (Non-Sanctioned)**

**Class 110: Colored Terrier Puppy Conformation.** Judged on their breed standard. *(Non-Sanctioned)*

**Class 111: Colored Terrier Dog Conformation.** Judged on their breed standard. *(Non-Sanctioned)*

**Class 112: Colored Terrier Bitch Conformation.** Judged on their breed standard. *(Non-Sanctioned)*

**Class 113: Champion/Reserve Colored Terrier Conformation.** 1<sup>st</sup> and 2<sup>nd</sup> place winners of classes 110 through 112. *No Entry Fee (Non-Sanctioned)*

**Section 3. Go to Ground (Non-Sanctioned)**

**Class 114: Puppy:** Open to colored/novice terrier types age 4 months up to 12 months *(Non-Sanctioned)*

**Class 115: Adult:** Open to Colored/novice terrier types one year of age or older *(Non-Sanctioned)*

**Section 4. BARN HUNT (NON-Sanctioned)** Open to any terrier types. The event will be a simulated “barn hunt” situation with multiple locations that the dog can access and check for quarry. The dog will be visible to the handler at all times. One location and one location only will have actual quarry available for the dog to locate and react to. The event will begin when the judge tells the handler to release the dog. The handler will establish the event time for each dog, when the handler believes the dog has successfully located quarry by telling the judge “MARK”. If the dog and handler together have successfully identified the location where quarry is present the time is recorded. If the handler calls “MARK”, and the dog is at a vacant location, the team is “NO TIME” and released from the event. The team with the fastest time to quarry correctly called “MARK” by the handler is the winner. The event is open to all Adult terriers. Each dog can compete only once for time. The maximum time allowed for each team is two minutes. *(Non-Sanctioned)*

**Class 116: Puppy under 12 months of age** *(Open to all puppy terrier types) NON-Sanctioned*

**Class 117: Adults over 12 months of age.** *Open to all terrier types one year and older. NON-Sanctioned*

**Section 4. Lure Coursing (Non-Sanctioned)**

**Class 118: Puppies up to 12 months of age under 12 ½”** *(Open to all puppies) NON Sanctioned*

**Class 119: Puppies up to 12 months of age over 12 ½” up to 15”**

**Class 120: 10” Puppies up to 12 month of age over 15”**

**Class 121 : Adults, 10” up to 12 ½”.** Open to dogs 1 yr and older

**Class 122 : Adults, 12 ½” up to 15”.** Open to dogs 1 yr and older

**Class 123: Adult over 15”** Open to dogs 1 yr and older

**Class 124: Veterans, 10” up to 12 ½”.** Open to dogs 6 yr and older

**Class 125: Veterans, 12 ½” up to 15”.** Open to dogs 6 yr and older

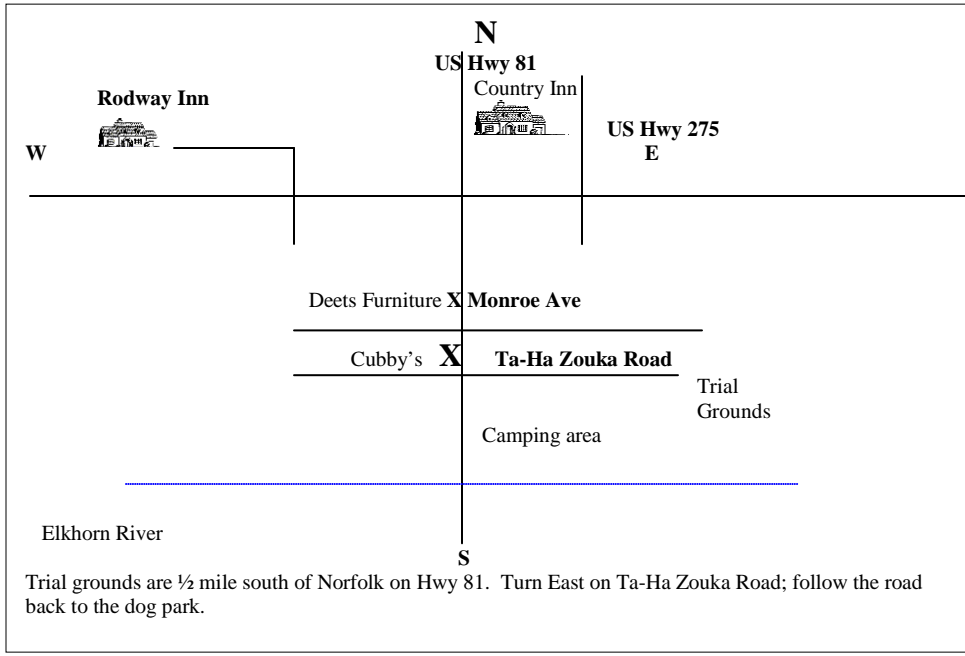

### **Adopting a friend**

Terriers are only placed in approved homes. We require anyone interested in adopting to complete an adoption application. We match potential homes with terriers based on the information in the application and with what we have learned about the dog. We may ask for a home visit or, if that is not possible, a photograph or video of the dog's prospective home. Rescue is a volunteer organization and relies upon donations and adoption fees in order to continue our efforts. We ask new owners for an adoption fee to cover veterinary costs, foster care expenses and any fees paid to shelters upon rescue. Adoption fees are \$150.00 for dogs over 1 years of age and \$175.00 for dogs under 1 years of age. New owners must sign a contract that states the dog will be returned to the rescue if it does not work out for any reason.
